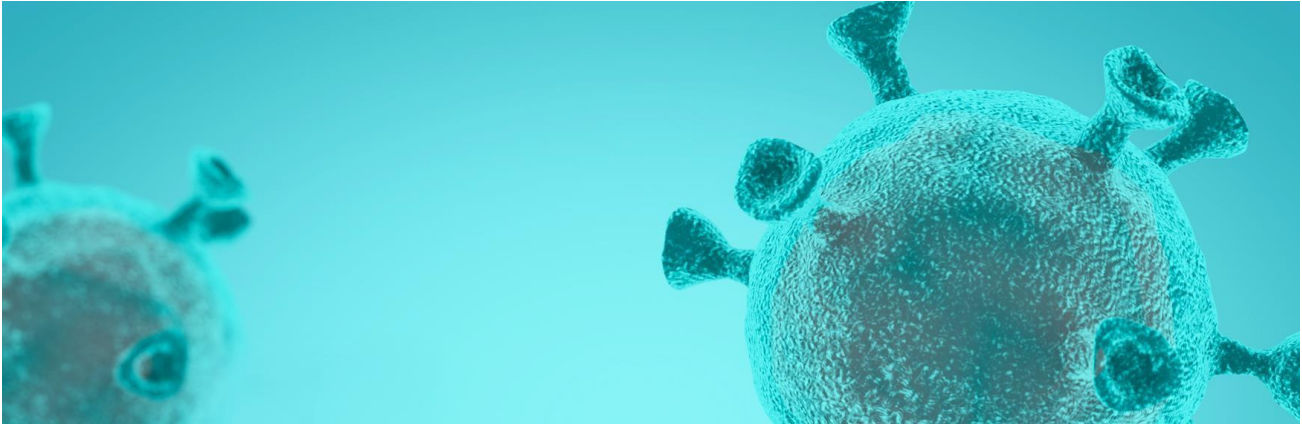




ONTIER MEXICO - COVID 19



SUSPENSION OF ACTIVITIES OF GOVERNMENT ENTITIES AND INSTITUTIONS AS A MITIGATION MEASURE TO THE SPREAD OF COVID-19.

March 31, 2020

On March 11, 2020, the World Health Organization classified the outbreak of the Covid-19 virus as a global pandemic. On March 19, 2020, the “*Consejo de Salubridad General de México*” (General Health Council of Mexico) recognized the epidemic as a serious disease of priority attention.

Below is a list of the Government agencies and entities that, as at 31 March 2020, have suspended work with the aim of mitigating the spread of the virus, and consequently have set deadlines and terms:

- *Secretaría de Educación Pública* (Secretary of Public Education)

From March 23 to April 20, 2020, deadlines and terms related to administrative proceedings and procedures before the Secretary of Public Education are suspended

(AGREEMENT number 03/03/20 suspending the time periods and terms related to the administrative procedures and formalities carried out before the Secretary)

- *Comisión Nacional de Hidrocarburos* (National Hydrocarbons Commission)

From March 23 to April 19, 2020, deadlines and terms related to administrative procedures and formalities before the “*Comisión Nacional de Hidrocarburos*” (National Hydrocarbons Commission) are suspended

(AGREEMENT declaring the suspension of deadlines and terms in the acts and procedures carried out in the National Commission of Hydrocarbons from Monday 23 March to Sunday 19 April 2020)

- *Secretaría de la Función Pública* (Secretariat of the Public Service)

From March 23 to April 17, 2020, deadlines and terms related to administrative formalities and procedures before the “*Secretaría de la Función Pública*” (Secretariat of Public Service) are suspended.

(AGREEMENT establishing the suspension of legal deadlines and terms in the Secretariat of Public Service, as a measure to prevent and combat the spread of the coronavirus COVID-19)

- *Secretaría de Comunicaciones y Transportes* (Secretary of Communications and Transport)

From March 19 to April 17, 2020, deadlines and terms related to administrative proceedings and procedures before the Secretary of Communications and Transport are suspended.

(ACUERDO por el que se hace del conocimiento público, los días que serán considerados como inhábiles para efectos de los actos y procedimientos administrativos sustanciados en las unidades administrativas de la Secretaría de Comunicaciones y Transportes con motivo de la contingencia coronavirus (COVID-19).)

- “Procuraduría Federal del Consumidor”
Consumer Protection Federal Agency

From March 23 to April 20, 2020, deadlines and terms related to administrative formalities and procedures before the “Procuraduría Federal del Consumidor” Consumer Protection Federal Agency.

(AGREEMENT that establishes the means of attention to complaints and procedures in the Consumer Protection Federal Agency and suspends the deadlines and terms indicated)

- “Dependencias de la Ciudad de México”.
(Mexico City Public Agencies)

From March 23 to April 20, 2020, deadlines and terms related to administrative proceedings and procedures before the agencies in Mexico City are suspended.

(Agreement suspending the terms and deadlines inherent in administrative procedures and formalities and granting administrative facilities for compliance with tax obligations, to prevent the spread of the COVID-19 virus)

- “Secretaría de Desarrollo Urbano CDMX”
(Mexico City Secretary of Urban Development)

From March 23 to April 20, 2020, deadlines and terms related to administrative proceedings and procedures before the Mexico City Secretary of Urban Development are suspended.

(Agreement defining the scope in matters of urban development of the fourth recital of the agreement suspending the terms and time limits inherent in administrative procedures and formalities and granting administrative facilities for compliance with fiscal obligations, in order to prevent the spread of the COVID-19 virus)

- “Comisión Federal de Competencia Económica” (Federal Economic Commission)

From March 23 to April 17, 2020, deadlines and terms related to administrative proceedings and procedures before the Federal Commission of Economic are suspended.

(AGREEMENT by means of which the Plenary resolves that the terms of some proceedings before the Federal Commission of Economic Competition will not apply).

- “Instituto Mexicano de Propiedad Industrial”
(Mexican Institute of Industrial Property)

From March 24 to April 19, 2020, deadlines and terms related to administrative proceedings and procedures before the Mexican Institute of Industrial Property are suspended.

(Agreement suspending the deadlines and not running legal terms in the period indicated of the “IMPI”).

- “Secretaría de Gobernación” (Government Secretary)

From March 24 to April 19, 2020, deadlines and terms related to administrative procedures and procedures before the General Direction of Games and Lotteries, as well as the Mexican Commission for Assistance to Refugees (COMAR) are suspended.

(AGREEMENT establishing the suspension of legal deadlines and terms in the proceedings of the Secretary of the Government indicated. The General Direction of Games and Lotteries, as well as COMAR. 24th March 2020.)

- “Comisión Reguladora de Energía” (Energy Regulatory Commission)

From March 24 to April 17, 2020, deadlines and terms related to administrative proceedings and procedures before the Energy Regulatory Commission are suspended.

(AGREEMENT number A/010/2020 establishing the suspension of legal deadlines and terms in the Energy Regulatory Commission, as a measure to prevent and combat the spread of the coronavirus COVID-19.)

- “Secretaría de Energía” (Secretary of Energy)

From March 25 to April 17, 2020, deadlines and terms related to administrative formalities and procedures before the Secretary of Energy are suspended.

(AGREEMENT establishing the suspension of legal deadlines and terms at the Secretariat of Energy, as a measure to prevent and combat the spread of the COVID-19 coronavirus)

- “Secretaría de Relaciones Exteriores” (Secretary of Foreign Affairs)

From March 27 to April 19, 2020, the deadlines and terms related to administrative formalities and procedures before the Ministry of Foreign Affairs are suspended.

(AGREEMENT to make known the days on which the applicable deadlines and terms will be suspended in the administrative proceedings and procedures carried out before the Ministry of Foreign Affairs, due to the coronavirus contingency (COVID-19))

- “Comisión Nacional Bancaria y de Valores”
(National Banking and Securities Commission)

From March 23 to April 19, 2020, deadlines and terms related to administrative proceedings and procedures before the National Banking and Securities Commission are suspended.

(AGREEMENT establishing the temporary and extraordinary measures and suspending some deadlines for the attention of financial institutions and persons subject to the supervision of the National Banking and Securities Commission, due to the coronavirus called COVID-19.)

- “Comisión Nacional del Sistema de Ahorro para el Retiro” (National Commission of the Retirement Savings System)

From March 26 to April 19, 2020, deadlines and terms related to administrative procedures and formalities before the National Commission of the Retirement Savings System are suspended.

(AGREEMENT establishing temporary and extraordinary measures and suspending some deadlines for the attention of participants in the Retirement Savings System because of the COVID-19.)

- “Secretaría de Economía” (Secretary of Economy)

From March 26 to April 19, 2020, deadlines and terms related to administrative procedures and formalities before the Secretary of Economy are suspended.

(AGREEMENT suspending terms at the Secretary of the Economy and establishing administrative measures to contain the spread of the coronavirus COVID-19)

- “Secretaría de Agricultura y Desarrollo Rural”
(Secretariat of Agriculture and Rural Development)

(AGREEMENT establishing the suspension of legal and administrative deadlines and terms in the Secretariat of Agriculture and Rural Development and its decentralized administrative bodies, as a measure to prevent and combat the spread of the coronavirus COVID-19)

- “Secretaría del Trabajo y Previsión Social”
(Secretariat of Labor and Social Welfare)

From March 26 to April 17, 2020, the deadlines and terms related to administrative proceedings and procedures before the Ministry of Labor and Social Welfare are suspended.

(AGREEMENT establishing the suspension of legal deadlines and terms at the Secretary of Labor and Social Welfare)

- “Instituto Federal de Telecomunicaciones”
(Federal Institute of Telecommunications)

The receipt of documents, the practice of actions and proceedings that fall under the jurisdiction of the supervisory body of the Federal Institute of Telecommunications are suspended from March 23 to April 19, 2020.

(AGREEMENT by which the Head of the Internal Control Organ of the Federal Institute of Telecommunications declares the suspension of the reception of documents in the Office reception desk and the practice of actions and diligences that correspond to the control organ, given the contingency of the coronavirus COVID-19.)

- “Cámara de Senadores” (Senate)

The deadlines and terms of the responsible bodies within the Senate are suspended to respond to the request of the National Institute of Transparency, from March 20 to April 19, 2020.

(AGREEMENT of the Board of Directors of the Chamber of Senators concerning the suspension of deadlines and procedures relating to outstanding obligations under the health measures adopted in response to the COVID-19 pandemic.)

- “Cámara de Diputados” (Chamber of Deputies)

The terms and conditions of the Evaluation and Control Unit of the Surveillance Commission of the Superior Audit Office of the Federation of the Chamber of Deputies are suspended from March 23 to April 17, 2020.

(AGREEMENT to inform that in the Evaluation and Control Unit of the Surveillance Commission of the Superior Audit Office of the Federation of the Chamber of Deputies of the Honorable Congress of the Union, from March 23 to April 17, 2020, the terms for the exercise of its faculties are suspended, including the procedures established in articles 103, last paragraph and 104, sections III, IV, VI, VIII and IX of the Audit and Accountability Law of the Federation, as well as in the General Law of Administrative Responsibilities)

- “Comisión Nacional Para la Protección y Defensa de los Usuarios de Servicios Financieros” (National Commission for the Protection and Defense of Financial Services Users)

The terms of the National Commission for the Protection and Defense of Financial Services Users are suspended from March 26 to April 17, 2020.

(Agreement by which it is made known to the general public that the National Commission for the Protection and Defense of Financial Services Users, suspends terms and deadlines, as well as personal attention in user service units and public service offices, for the period from March 26 to April 17, 2020)

- “Comisión Nacional de los Derechos Humanos”
(National Human Rights Commission)

The terms of the National Human Rights Commission are suspended, effective March 26, until a new agreement is issued.

(Agreement suspending the terms at the National Human Rights Commission as a preventive measure to deal with the coronavirus (COVID-19).)

- “Instituto Nacional de Transparencia, Acceso a la Información y Protección de Datos Personales”
(National Institute of Transparency, Access to Information and Personal Data Protection)

The sessions of the full National Institute of Transparency, Access to Information and Personal Data Protection are provisionally suspended.

(AGREEMENT by which the diverse ACT-EXT- PUB/20/03/2020.02 is modified and added in the sense of provisionally suspending the sessions of the Plenary of this Institute in accordance with the Agreement by which the preventive measures that should be implemented for the mitigation and control of the health risks that the SARS-CoV2 virus (COVID-19) implies, of the Secretary of Health, published in the evening edition of March 24, 2020)

- “Centro Nacional de Control de Energía”. (National Energy Control Center).

The deadlines and terms of the National Energy Control Center are suspended from March 26 to April 19, 2020.

(AGREEMENT declaring the suspension of deadlines and terms in the acts and procedures carried out before the Administrative Units of the National Energy Control Center, from Thursday, March 26 to Sunday, April 19, 2020)

- “Eventos de más de 50 personas, establecimientos y centros educativos en la Ciudad de México”.
(Events of more than 50 people, establishments and educational centers in Mexico City).

The use of any establishment considered to have a neighborhood impact, events involving more than 50 people and educational centers is suspended from March 26 to April 19, 2020 in Mexico City.

(First Agreement determining the temporary suspension of activities of the above-mentioned educational establishments and centres, as well as public and private events over 50 people, in order to prevent the spread of COVID-19)
